Outstanding Service Award **American Association of Meat Processors**

Minutes of the 2004 AAMP Board of Directors Meeting, American Convention of Meat Processors, Grand Rapids, Michigan:

“Steinman moved that the Outstanding Service Award and Accomplishment Award Committees be disbanded after the convention and that the awards be determined by the staff soliciting member nominations and making recommendations to the Board, enabling the Board to determine the winners rather than a committee(s). Halls seconded the motion, which was approved”.

The **Outstanding Service Award** is an honor to be bestowed on **affiliated associations, officers, secretaries or leaders** by the American Association of Meat Processors (AAMP).

In 1995, at the AAMP Board of Directors meeting, the Directors voted to identify these associations and/or leaders whose dedication and enthusiasm have elevated the association to an outstanding degree. The AAMP Outstanding Service Award will recognize noteworthy state, regional, or provincial associations or remarkable leaders.

This Award may be presented for past or present accomplishments. If the Nominee is an individual or individuals (and not an "Association") - they may be a member of AAMP or a non-member, deceased, or retired (no longer involved in the industry). Nominees may be past or present state, regional or provincial association executive secretaries or other leaders who have devoted unusual energy and leadership to the Association, expanded its membership, etc. Or, a nominee may be an outstanding state, regional or provincial association which has provided important educational opportunities for its members, led concerted efforts in the area of legislation or served as a reservoir of knowledge and assistance for its members.

A mailing is sent to the AAMP Affiliated Associations to give them an opportunity to request a Nominee Form from AAMP for submitting a nominee for this Award. An article is included in the AAMPifier giving a description of the Award and stating a Nominee Form may be requested from AAMP.

The recipient(s) for the AAMP Outstanding Service Award is selected before the Convention. AAMP recommends the Award recipient(s) to the AAMP Board of Directors for approval by mail ballot. A plaque is presented to the Award Winner(s) at the Welcoming Session held at the American Convention of Meat Processors (5/16/2001 - at previous conventions the plaque was presented at the State Officers Conference). The Award Winner does not have to be present to receive this Award. ***The AAMP Outstanding Service Award is confidential until the presentation!***

AAMP Will Carry Over The Names Of All Nominees For Consideration A Second Year - Approved by the AAMP Board of Directors at the 1997 American Convention of Meat Processors.
