HOW TO ATTEND THE 73RD AMERICAN CONVENTION OF MEAT PROCESSORS WITHOUT BECOMING AN EXHIBITOR...

Policies set by AAMP's Board of Directors tightly control admission of non-exhibiting supplier personnel to the show. Interested distributors are encouraged to contact affiliated manufacturers who are exhibiting at the show. The following fees will apply to all non-exhibiting companies:

- One visitor from an AAMP Member firm - \$545, Additional person - \$75
- One visitor from a Non-Member firm - \$845, Additional person - \$100
- One day only for AAMP Members and Non-Member firms - \$250

Suppliers attending under one of these options will receive a badge admitting them to the exhibit hall during exhibit hours (July 26, 1:00 - 4:30 PM; July 27, 9:30 AM - 12:30 PM; and July 28, 12:30 PM - 3:30 PM) with the understanding that **they will restrict their activity to an evaluation of the show and will not engage in selling or promotion of any kind.** Your badge will also grant you access to educational sessions being held in the morning.

Alternative: For non-exhibiting supplier companies who wish to have an overview of the show, a 10-minute escorted walk-through tour will be conducted at 1:30 PM on July 26 or July 28, or 10:00 AM on July 27.
